Felda Global Ventures Holdings Berhad

"In line with international commitments and in compliance with the Environmental Quality Act 1974 and applicable local laws and regulations in jurisdictions which FGV operates, to ban open burning. FGV Group employees and contractors working in FGV Group premises shall not perform any open burning. There shall be no open burning during land clearing and replanting activities as well as for the purpose of disposing domestic waste or any other purpose except for controlled burning for the management of pest and disease (with prior approval) as specified in 'Guidelines for the Implementation of the ASEAN Policy on Zero Burning 2003.

FGV Group shall develop robust fire prevention measures by enhancing the Group's capacity in fire control through a series of initiatives and training programmes including simulation exercise on fire - fighting, forming dedicated emergency response teams, and establishing guidelines on fire prevention and management decision-making to deal with fire in emergency situations. The Group shall be proactive in fire monitoring and updating local authorities on the occurrence of fires, if any, within and surrounding the Group premises."
