- Where feasible, explore options for peat restoration

# 3. No Exploitation of People and Local Communities

- Respect and support the Universal Declaration of Human Rights
- Respect and recognize the rights of all workers including contract, temporary and migrant workers
- Facilitate the inclusion of smallholders into the supply chain
- Respect land tenure rights
- Respect the rights of Free Prior and Informed Consent (FPIC) of indigenous and local communities
- Resolve all complaints and conflicts through an open, transparent and consultative process.

Core to our policy is a commitment to creating a transparent sourcing network with full traceability. We look forward to close consultation with communities, NGOs, our industry partners, and others to ensure effective implementation of these policies.
