T4T is an online system to help palm oil refineries engage their suppliers to improve practices on the ground and report progress. It is a tool to help meet the growing market demands for NDPE performance in a systematic yet efficient manner that significantly improves understanding and communications.

Self Assessment

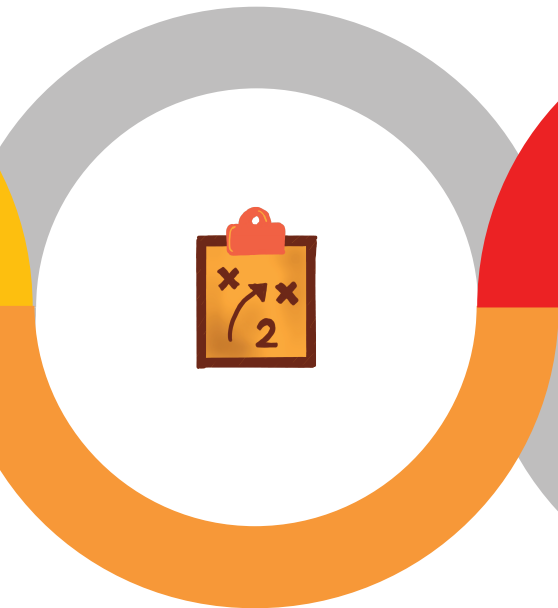
- ✓ Suppliers begin by diagnosing gaps in their own operations.

- ✓ Refinery's reporting to international markets becomes transparent, measurable and easy to understand.
