



When employing migrant workers, it is essential that companies invest in translating key documents (such as contracts and important notices) into a language that the workers can understand. This will ensure workers understand the terms and conditions of their employment, and avoid misunderstandings about the nature of the work expected.

Some of the services listed below also offer interpretation services. In addition to translating documents, it is extremely important that companies use interpretation into the native language of the worker for in-person situations such as interviews, trainings, grievance mechanism, etc.
